## Instruction to Examinees

- 1. Go through the Admit Card carefully. In case of any discrepancy inform the Office of the District Magistrate & Collector, Nadia (Establishment Section) immediately.
- 2. No Examinee shall be allowed to enter the Examination Centre without the Admit Card.
- 3. Date of examination: 20-07-2025 (Sunday), time:12:00 PM to 1:00 PM (60 minutes).
- 4. Report to the Examination Centre One and half hour before the commencement of examination. Examination hall will be opened 30 minutes before the commencement of examination.
- 5. Take the allotted seats 15 minutes before the commencement of examination. Question cum Answer Booklet will be distributed 5 minutes before the commencement of examination.
- 6. Examinee to fill up his/her Name, Roll No., Registration No., Name of Examination Centre & all other details and sign in the specific space given on the Question cum Answer Booklet. Invigilator will verify all the details of the examinee & sign it.
- 7. Examinee should NOT write his name or sign or put any mark anywhere else in the Question cum Answer Booklet which may identify him. Any type of violation of this clause will lead to cancellation of candidature.
- 8. To open the Question cum Answer Booklet on ringing of bell at the commencement of examination at 12:00 hrs. (12 noon)
- 9. Examinees will NOT BE ALLOWED to enter the exam hall/room after commencement of examination and shall NOT be allowed to leave the examination hall/room until the examination is over.
- 10. If any examinee is found to carry Question cum Answer Booklet outside the examination hall during examination or after completion of examination, HIS/HER CANDIDATURE WILL BE CANCELLED.
- 11. Examinees are ALLOWED to carry ONLY Admit Card of the Contractual Data Entry Operator Recruitment Examination, Black Ball Point Pen(s) and Originals of - Aadhaar Card / Voter ID Card (EPIC) / Driving Licence / Passport (for identification purpose) inside the examination hall and nothing else.

Instrument/Geometry/Pencil Boxes, any kind of paper/stationery/textual material (printed or written), Eatables, Lighter/Match Boxes etc. inside premises where the examination is being conducted. Any infringement of these instructions will entail disciplinary action including ban from future examination and lodging of FIR with Police. Candidates are also advised not to bring any valuable/costly items to the Examination Centre, as safe keeping of the same cannot be assured.
